RULES AND CONDITIONS

- **No tables, chairs, umbrellas or shelter will be provided by the festival committee.**
- Each stall is responsible for their own cooling facilities.
- **Power Source is limited to 10 amp per stall. Only one electrical appliance per power source is allowed. Electricity is available seperately at R50.**
- Stallholders are responsible for their own extension cords and it should be in a good, working condition.
- The stallholder will only display and sell goods as indicated on this form and that has been approved by the committee.
- The committee will take no responsibility for any damage or injuries the stallholder might experience.
- **Applications closing date 11 November 2011 ! No late applications.**
- **Stall numbers will only be allocated after the closing date.**
- **PREMISES - The market display will be in front of Malmesbury Town Hall, NG Dutch Reformed Church and in the Town Hall.**
- **SIZE OF THE STALLS:**
 Foodstalls and Flea market – 3 x 4 meter (3m Frontview, 4m Depth) If more space is needed, you must pay for 2 stalls.
- No Vehicles will be allowed on the premises. Delivery must take place before 15h00.
- Please report to the Tourism Office from 14h00 and then you can start with your stall. No stalls before the time please!
- The stallholder must keep the area around his stall clean and hygienic.
- Cancellation of stalls after 18 November 2011, only 50% of the cost will be paid back to you.
- Cancellation within 48hours you will loose 100% of the costs.
- Payment must be made before **18 November 2011**, otherwise no stall will be allocated.
- **No BB Guns or fireworks** are allowed on the premises. All items being sold by stallholders is the responsibility of the stallholder and you will be accountable for any harm done to people or equipment.
- If your products do not sell, the festival committee will take no responsibility.
- **NO EXCEPTIONS.**

All stalls must be ready on Friday 2 December 2011 at 15h00 – 22h00, afterwards you must pack up and clear the premises at 23h00.
